Interested candidates should apply by EMAIL with a CV (containing qualifications, achievements, age, email ID and contact number details along with a covering letter), passport photograph and photocopies of relevant documents. 2. Last date for submission of application is **21st January 2026**.
3. Age limit as on **1st January 2026** is 35 years for general candidates, relaxation to SC/ST/OBC candidates as per GoI Rules.
4. Selection will be done on the basis of interview (on-line) and academic background. The interview date for the shortlisted candidates will be informed through email. Candidates will be required to keep all the testimonials related to education and community certificate (if applicable) in original during the interview. For selected candidates the original certificates would be verified. Self-attested photocopies of the certificates and two recent passport -size photographs should be submitted during the joining, if selected.
5. The tenure will be around one year or co-terminus with the project. The selected PROJECT ASSOCIATE-I will be allowed to register for Ph.D. program of the Consortium by following the due process for the same.
