3. All the eligible candidates are required to bring the following documents in original and one set of self-attested copy during the written test/skill test

  - (b) Govt. approved valid photo ID Card.
  - (c) Original Mark sheets and certificates, in support of their educational qualifications.
  - (d) Documents in support of previous employments (if employed).
  - (e) No objection certificate/ copy of forwarding letter from the employer, if application sent through proper channel (if employed in a Government/ Government Aided / Government Undertaking Organization).
4. This Institute will not consider any request for extension of time for submission of above mentioned documents during physical documents verification before the skill test. Failing to produce above documents, the candidates will not be permitted to appear for Skill Test.
